Members had been circulated with papers relating to various draft applications to the Fund for consideration.

Members received a presentation from C Hawkes, assisted by T Miller, I Elenor and H Staddon in respect of an application to support a project titled "Growing for Health and Well Being."

Members received a presentation from C Hawkes, assisted by S. Elstob, T Miller, I Elenor and H Staddon in respect of an application to support a project titled "Cycling for the Future".

Members received a presentation from S. Howell in respect of an application to support a project titled "SAVE Climate (Somerset Action in Villages for the Environment & Climate)".

Members received a presentation from J Nicholson, in respect of an application to support the repurposing of the Multi Use Games Area situated in the grounds of the Victory Hall.

Members had an opportunity to raise questions of the presenters on the various applications. The Chairman moved to the vote in respect of support, or not for the various project applications.

The Parish Council resolved to support the project " Growing for Health and Well Being" unanimously.

The Parish Council resolved not to support the project " Cycling for the Future" by a majority, of 4 votes to 2.

The Parish Council resolved not to support the project "SAVE Climate (Somerset Action in Villages for the Environment & Climate)". by a majority of 5 votes to 2.
