1 ELECTOR'S SESSION:

2 PRESENTATION OF THE PARISH COUNCIL ACCOUNTS TO 31 MARCH 2021 (The Clerk)

3.1 The total receipts for the year was £43,673; £28,235 of this was the Precept, £6,895 Grant money to assist Stogursey Community Network during the Covid Pandemic. Payments for the year totalled £43,118. The normal annual expenditure items such as insurance, audit, grass cutting and amenity enhancements was similar to the previous year and variations in difference included support to Stogursey Community Network an increase in Clerk's salary due to the departure of the Gillian Orchard as Clerk.

3.2 The net bank balance at the 31.3.21 of all bank accounts was £66,780.

3.3 The schedule of the parish council assets totalled £132,268.

3.4 The accounts will form the basis of the Annual Audit to be submitted to the External Auditors by 2 July 2021.

4 ANNUAL REPORT OF THE CHAIRMAN (Cllr Chris Morgan)

4.1 The Chairman presented his report to 31.3.21. Copies had been circulated to members and it will be placed on the parish website (Stogursey-online.uk). The report covered a brief resume of events over the past twelve months.

4.2 The Chairman appreciates the work of the Councillors and the Clerk for all their hard work and support over the last 12 months. We have been able to work successfully over the last year and he hopes we can continue to do our best for the parish and community over the coming year. There were no questions or comments.

5 REPORT OF THE STOGURSEY CHARITIES (Pauline Kaye, Steward):

A copy of the William Pawlett Almshouse accounts and the Stewards Report was circulated. The Pandemic has curtailed their work during 2020-2021, meetings have not been held. Some work has been carried out by charities that look after the Almshouses in Lime Street and St Andrews Road. There is an interview process ongoing for a new resident to a flat in St Andrews Road. There were no questions or comments.
